## **TOURNAMENT RULES YOU MUST AGREE TO THESE**

1. In order to enter the tournament, your USGA handicap index must be higher than 22. (Note, this is not a permanent rule. It changes based on Mr. Doermaet's handicap). You must provide proof of your handicap in your application and on the day of the tournament.
2. The Albert J. Doermaet, Jr. Average Man Invitational will use an unhandicapped "horse race" format.
3. 11 golfers will tee off of the tenth hole at Royal Melbourne Country Club in Long Grove, IL, at 1:00 PM on October 8, 2007.
4. The 11 golfers will be competing for a \$300,000 prize.
5. The golfers will tee off in an order determined by tournament director and rules official Peter deYoung.
6. The golfers will abide by the USGA Rules of Golf and the rules listed on the local rules sheet.
7. If the golfers do not abide by the Rules of Golf or the interpretations of the rules by Peter deYoung, the tournament's rules director, they can and will be disqualified from the tournament.
8. Each player will complete the tenth hole. The two players with the highest score on the tenth hole will be eliminated from the tournament.
9. In the event of a tie for the highest score, Peter deYoung, the tournament's rules director, will ask the tied players to compete in either a chip off or putt off.
10. deYoung will place a golf ball somewhere on the putting surface or in the fairway within 50 yards of the green. The tied players will each have one chance to hit a shot from that spot. The player whose ball ends up farthest from the hole will be eliminated.
11. Nine players will tee off on the eleventh hole and will repeat the entire process. On the 11th, 12th, 13th, 14th, 15th, 16th, 17th, and 18th holes, only one player will be eliminated.
12. The winner will be the only player not eliminated after nine holes. That player will receive the \$300,000 cash prize.

## **RELEASE AND WAIVER OF LIABILITY & INDEMNITY AGREEMENT**

Caution: Please read this agreement carefully. By signing this agreement you are giving up certain valuable legal rights to sue the Albert J. Doermaet Average Man Invitational or ACI, their officers, members, directors, managers, agents, heirs, and assigns for any personal injuries or death you may suffer as a result of your presence and/or participation in the fourth annual Albert J. Doermaet Average Man Invitational ("The TOURNAMENT").

Warning: Participating in The TOURNAMENT could cause serious injury or even death.

Read and fully understand each provision of this agreement and so indicate by initialing each provision in the space provided after each provision. Sign and date the form.

IN CONSIDERATION OF ACI and the Albert J. Doermaet Average Mänge Invitational, their officers, members, directors, managers, agents, heirs, and assigns allowing (please print your name) \_\_\_\_\_ (hereinafter referred to as "the Participant") to utilize the facilities and equipment and to participate in The TOURNAMENT and its associated activities, it is agreed that:

- 1) **PARTIES INCLUDED:** The Participant understands that this agreement includes ACI and the Albert J. Doermaet Average Man Invitational/their officers, members, directors, managers, agents, heirs, assigns, and volunteers (hereinafter referred to in this Agreement as "the Released Parties").
- 2) **ASSUMPTION OF RISK:** The Participant is fully aware that participation in the TOURNAMENT and all associated activities is a calculated risk and contains inherent risk and dangers ("including serious injury or death), that no amount of care, caution, instruction, or expertise can eliminate. The Participant knows and understands the scope, nature, and extent of the risks involved in the activities contemplated by this agreement. The Participant voluntarily and freely chooses to incur any and all such risks and dangers.
- 3) **EXEMPTION FROM LIABILITY:** The Participant hereby fully and forever discharges and releases the Released Parties from any and all liability, claims, demands, actions and causes of action whatsoever arising from personal injuries, conscious suffering, death, or property damages sustained by the Participant arising out of participation in the TOURNAMENT or while participating in any other activities contemplated by this release and included in the TOURNAMENT. Exemption from liability includes loss, damage or injury resulting from the negligence of the Released Parties or from any other cause or causes.
- 4) **COVENANT NOT TO SUE:** The Participant agrees for himself/herself and his/her heirs, executors, or administrators, not to institute any suit or action at law, or otherwise against the Released Parties nor to initiate or assist the prosecution of any

claim against the Released Parties for damages, or course of action, which the participant, his/her heirs, executors or administrators hereafter may have by reason of injury to the person of the Participant or to his/her property arising from his/her presence and/or participation in the TOURNAMENT, as contemplated by this Agreement.

5) INDEMNITY AGREEMENT: The Participant agrees, for himself/herself and his/her heirs, executors, administrators, or assigns to indemnify and hold harmless Released Parties from any and all losses, claims, actions or proceedings of any kind which may be initiated by the participant and/or any other person or organization. THIS INCLUDES REIMBURSEMENT OF ALL LEGAL COSTS AND REASONABLE COUNSEL FEES INCURRED BY THE RELEASEE, the participant, and indemnified parties, or any of them for defense of any such actions which may hereafter arise directly or indirectly from his/her presence and/or participation in the TOURNAMENT while engaged in the TOURNAMENT or activities contemplated by this agreement.

6) CONTINUATION OF OBLIGATION: The Participant agrees and acknowledges that the terms and conditions of the above provisions, including ASSUMPTION OF RISK, EXEMPTION FROM LIABILITY, COVENANT NOT TO SUE, and INDEMNITY AGREEMENT shall continue in full force and effect at all times, and shall be binding upon heirs, executors, administrators, or assigns of the participant of his/her estate.

I hereby expressly recognize that this Agreement is a CONTRACT pursuant to which I have released any and all claims against the Released Parties resulting from my participation in the TOURNAMENT, including any claims caused by the negligence of the Released Parties.

I have read this agreement carefully and fully understand its contents and sign it of my own free will. I further certify that I am (18) years of age or older. I also certify that I have read, understand, and will abide by the rules of the TOURNAMENT.
